Nov. 11, 1985.

On November 11, 1985, the regularly scheduled Town Council Meeting was held at 7:30 p.m. Present was Mayor Rogers, Carolyn Knicely, Randall Fitzgerald, Harold McClure, Robert Spriggs, Jennings McClure and Bruce Morris. The minutes of the September meeting were read and approved as read.

Bank statements were read as to deposits, checks drawn, and current balances. Mayor Rogers moved that the balance due Kenton Meadows Company of approximately \$3000. be paid from the predetermined fund. Mr. McClure seconded the motion. All Council members voted in favor.

Mr. McClure reported to the Council concerning a town library. Lois Thompson of the State Libraries Commission was supposed to contact the Council with reference to state funding. Building size was discussed along with possible locations. The State Lib. Commission, according to Mr. McClure's understanding, paid a lot of the bill and we matched the funds. It was also noted that the Board of Education supplements libraries in Sutton and Passaway. Mr. McClure will continue to investigate the possibility and report his findings to the Council.

Wash Truck up was discussed. Mayor Rogers agreed to ascertain a date for the pick-up and publicize it in the paper and to contact Bob Spriggs. Mr. Spriggs would then prepare signs to post with reference to the pickup. All Council members were in favor.

Mayor Rogers reported that Loren Knicely had indicated to him that the town had a

little risk, with reference to insurance; Mr. Kuceley will check on a policy for the Town.

Mr. Spriggs then reported that he was selling a piece of property that was landlocked streets and alleyways. There are, at this time, no proposed streets and alleyways. He requested that the Town abandon the indicated area. After much discussion, Council decided that they did not have enough information to determine the specific area, but were not inclined to abandon any area of the Town's streets or proposed streets and alleyways or property.

The meeting was adjourned at 8:40.

relating probable benefits & requirements of the Town to obtain the grant. The first requirement to be handled was a Town Meeting. The 27<sup>th</sup> of February was designated as the 1<sup>st</sup> Town Meeting. Mr. McCune moved that we advertise the Town Meeting. Mr. Spriggs seconded the motion.

Good Insurance was discussed and tabled. Mr. McCune reported that he had spoken with Harley Brown concerning the pavement which was torn up at the foot of the Church Hill. Mr. Brown had retained enough cash to make the repairs when weather permitted.

Budget Revisions were discussed and okayed. The meeting was adjourned.

The budget was discussed. In view of the limited resources of the Town it was agreed that any money spent would go to maintaining the lights for the Town if possible.

The minutes of the last meeting were read and approved as read. Bank balances were read.

The Council agreed that the application for Federal funds to aid those in the community with housing problems such as insulation, heating, plumbing, etc., should be forwarded to the appropriate agency for review. Sentiment of Town Members and Members of the Community certainly were in favor of submission of the application.

A letter addressed to the Town from the Dept. of Highways was presented. After discussion it was agreed that no taxes of any sort had been paid to the Town and a letter would be directed to the Dept. of Highways advising them of this fact.

Before adjourning Council unanimously agreed that Mayor Rogers and Mrs. Morris should draft the new budget.

Meeting was adjourned at 8 p.m.

The regular meeting of the Flatwoods Town Council was held on June 9, 1986 in the Flatwoods Community Building.

Attending were Mayor Rogers; Council members: Randall Luzader, Harold McCune, Robert Spriggs and Carolyn Knealey.

The Mayor called the meeting to order. He announced that the Town's budget had been completed and approved. The operating budget is approximately \$8700.<sup>00</sup> for the 1986-1987 year. The Mayor next stated that he had received approval for ten youths and one supervisor to work for the town under the Governor's Summer Youth Program. Randy

Ruzader will be responsible for overseeing the program.

The potential danger posed by the parking of a vehicle at the old Central Supply Bld. Garage at the foot of the hill at the church was discussed.

Mayor Rogers said he would see Jay Barrette about taking care of the problem.

After mentioning the need to begin work on compiling a written Town Ordinance, the Mayor adjourned the meeting.

The regular meeting of the Town Council of Flitwoods met at 7:30, August 11, 1986.

Mr. Harold McCune, Jennings McCune, Mr. Randall Ruzader, Mr. Robert Spriggs, and Mrs. Brenda Morris and Mr. Keiser Dean were in attendance.

Mr. Ruzader presented the Town Council with Mayor Rogers' handwritten resignation. The resignation read as follows.

"To The Members of Town Council"

This letter is to inform you of my resignation as Mayor effective August 11, 1986. It has been in most cases a privilege to serve. As I leave I want to call your attention to the need for a set of ordinances, town ordinances. I have tried to get them but was not successful. Respectfully,

James Rogers.

Bob Spuggs moved to accept the resignation of Mayra Rogers. Mr. McClune seconded the motion. The Council voted unanimously to accept the resignation tendered. Subsequently, discussion resulted in unanimous agreement that Mayra's responsibilities would then fall on Town Recorder - Brenda Morris would, consequently, temporarily act as Mayor.

Insurance was the next topic of discussion. Lonan Knealey was to have been present but was apparently unable to appear.

Jennings McClune agreed to contact Mr. Knealey and schedule an additional meeting. All members agreed that the subject of liability insurance was significant to warrant an additional Town Meeting.

All council members agreed to make every effort to be present regardless of how short notice.

Brenda Morris brought up the subject of bonding. She advised council that in order to be in compliance with State Tax Regulations she needed to be bonded. No member knew the procedure for bonding or what had been done in the past. It was agreed to discuss this with Lonan Knealey on his visit.

Some discussion was had with reference to the location of the deed to the Community Bldg. No one knew.

The meeting was adjourned at 8:10 p.m.

The minutes of the last meeting were read and approved as read. Carolyn Kuceley moved that the Electrical Bill be paid. Jennings McCune seconded. Vote unanimous.

Gunton Feed and Hardware bill was mentioned, along with a discussion of need for file cabinet. Carolyn Kuceley found an old minutes where purchase for a file cabinet had been approved. Council decided this definitely needed to be done.

Harry Kye then addressed the council with a lengthy presentation regarding liability insurance for the town.

Harold McCune moved that we go with Mr. Kye as our "voice" for representation. Jennings McCune seconded. Vote unanimous.

Discussion was then had regarding verification of Health Dept. Approval for Sewage System of Church construction under the responsibility of Benny Cugger. This was needed.

Carolyn Kuceley advised us that vacancies on the Parks & Recreation Board were coming up and these needed to be considered at a future meeting.

At 8:50 p.m., the meeting was adjourned.

Minutes for March 16, 1987

The Council members met in a special meeting on Monday, March 16 with Randy Jagers, Harold McLean, James McLean, LeRoy Spry, and Cecily Knealy present.

The meeting began with the reading of a letter of resignation as recorder/treasurer by Brenda Martin dated for Jan. 1, 1987. The Council unanimously agreed to accept the resignation but to report in the minutes that the acceptance was for Mar. 16 and although it was dated for Jan 1, it was not delivered to Council member Cecily Knealy until Mar. 11, date of letter postmark.

The Council requested Mrs. Knealy to obtain key to Community building which was delivered to Mrs. Martin during the August 1986 meeting when she became acting Mayor after the resignation of James Jagers.

On a motion made by Robert Spry which was seconded by Harold McLean, the following new Council members were appointed to serve until the July term begins:

Mayor - Phillip Knealy

Recorder - Cecily Knealy

Treasurer - Ronald B. Jagers

Council member - Rev. Sheila Brydson

The minutes for Sept. were read and approved.

However, since the Oct. minutes were not written in the record

book returned by Mrs Morris,  
the Council agreed that the  
minutes should reflect the following  
action taken at the Oct. 12, 1986 meeting  
which was attended by Councilman  
Cathy Kucely, Jennings McKeene,  
Robert Spurr, and Rowell Snyder:

- 1) Approval for Incheon Great  
from 6:00 - 7:30<sup>pm</sup> on Oct 30  
followed by a Halloween  
party at the Community building.  
The Council approved paying  
the Flatwoods Auxiliary \$100.00  
toward the party.
- 2) the appointment of Marynell  
The Coy as ~~rep~~ representative  
on the Park & Recreation Board  
for a 3-year term, replacing  
Jim Logan.

Mrs. Kucely reported a balance  
of \$4,441.63 in the General Fund  
and \$ 748.69 in the Coal Seizure  
account, bringing both totals to  
\$ 5,190.32.

It was decided that checks were  
to be signed by the appointed mayor  
and appointed treasurer and that  
after acquiring signature of the  
board, Mr. Jordan would pay  
an outstanding bill to Latta Seed  
& Hardware in the amount of \$212.46  
and bring the Mayor's bill paid  
bills up to date. Payment of other  
bills - namely, tax audit, dues to  
Municipal League - would be discussed



March 23, 1987

A special session of the Town Council of Shelburne met at 7:00 on March 23, 1987 at the Community Building, with the following members present: Mayor Phillip Knealey, Recorder Carolyn Knealey, Treasurer Ron Jordan, Council members Randall Fitzgerald, Harold McCrene, Jennings McCrene, and Robert Sprigg.

The minutes for March 16 were read by the Recorder, who stated that the financial report given on that date did not reflect Revenue Sharing money.

The treasurer reported the following balances: 4,853.12 in General Fund  
748.69 in Local Assistance Fund

On a motion made by Mr. Sprigg and seconded by Mr. Fitzgerald, the Council gave the treasurer authority to pay \$455.00 to the WV State Dept. for the January audit.

Under old business, the Council voted to pay \$125.00 to cover the next 3 months of liability insurance to the WV Risk Insurance. This was on a motion made by Mr. Jennings McCrene and seconded by Harold McCrene.

Under new business, the budget submitted by Mrs. Knealey and Mr. Jordan was approved.

A motion was made by Harold McCrene and seconded by Randy Fitzgerald to authorize Mr. Jordan to change Revenue Sharing money into the General Fund. Mr. Jordan said the action was advised to ~~him~~ by a State Tax auditor

After some discussion, the decision to vote on the 10-year contract with the power company for lights was tabled until the April meeting.

Acting upon a motion made by Mr. Ferguson and seconded by Mr. Spry, the town decided the following ordinance: All dogs must be tied during the garden season of April 17 June 30.

Obviously, the owner will be responsible for any damages done by the animal. Mrs. Kruceley was instructed to have this published in the County news papers.

A resolution supporting Region VII Planning and Development Council was tabled until after a bill from named agency was received from former mayor James Pope.

In other action, Mr. Jordan was instructed to contact the mayor of Sutton concerning spring clean-up day for the Town of Statewood.

Since the lying meet be laid on the 3rd Tues in April, the Council agreed to hold its next regular meeting on April 21. This meeting would be preceded by a Town Meeting <sup>in the PM</sup> to select nominations for the June 2 ballot.

The meeting was dismissed at 8:10.

April 21, 1987

The regular meeting of the Flatwoods Town Council began at 7:30 at the Flatwoods Community Building. Present were Mayor Phillip Kuceley, Recorder Cindy Kuceley, Treasurer Donald Jordan and Council members Jennings McEneaney, Robert Sprigg, Sheila Baughman, and Hardy Snyder.

After the meeting was called to order, a representative from the power company presented and explained the franchise contract, renewable for fifty years. The Council agreed to allow him to run advertisement for two weeks and return for next Council meeting to pick up signed agreement.

The minutes for March were then read and approved. The treasurer reported a balance of \$5190.27 in the General Fund and \$748.69 in Coal Severance (totalling \$5,938.96) after he had paid \$947.40 of bills to Monongahela Power Company, State of WV Dept. of HV for audit, and Sutton Seed and Hardware, + liability insurance.

Mr. Jordan was authorized to pay two-year fee to the Region VIII Planning and Development Council in the amount of \$145.80.

Under old business, signing a 10-year contract for street lights was again tabled until Mr. Kuceley can talk with John Galison from the power company.

Under new business, Mrs. Baughman questioned the absence of flashing lights at the railroad crossing. Mr. Jordan explained that in the past several years requests were made for such a light, but since the tracks do not cross a state or federal highway, it was not required to have lights. However, Mr. Knealey agreed to look into the matter.

The Council gave the Recorder permission to engage Duality Printing to print ballots for the June election and to contract three workers to hold the election. Mr. Jordan will take care of acquiring the ballot box. Since the other towns are holding election on June 9, the Council agreed to change the election date from June 2 to June 9.

The levy was established at the following rates: Class I property, 12.5¢, Class II property, 9.5¢; Class III property, 5.0¢.

Since no one showed for the town meeting, the Council made nominations for the June election. After these nominees were contacted by various Council members, the ballot will read as follows:

The regular town council meeting was held on May 11, 1987 at 7:30 in the Flatwoods Community Building with the following members present: Mayor Phillip Knealy, Recorder Carolyn Knealy, Treasurer Ronald Jordan, Council members Sheila Balfour and Robert Sprigg.

Representatives from Monongahela Power Co. came to discuss agreements with the town. Gary Edwards explained that the franchise agreement couldn't be signed until <sup>50 days</sup> 30 days after the presentation of agreement, and that time was not yet up. He asked to return for the June meeting. John Gibson answered Council's questions concerning the 10-year lease contract. After discuss, Council agreed to sign our copy and return to the power company.

At the regular meeting continuing, the April minutes were read, and a Treasurer's report given: \$748.69 Coal Severance, \$5733.88 General Fund, totalling \$6582.57.

Ballot printing was discussed under old business. Instead of engaging Quality Printing for the ballots, those present agreed to having them printed by the Journalism Dept. at Bluff Co. High School.

On June 8, 1987 Mayor Phillip Knealy, Manager Lon Jordan, and Recorder Caroly Knealey met with the representative from Mongohelia Power to sign the approval franchise agreement <sup>between</sup> the power company and the town of Shattuck.

- 3) failure to prepare a financial statement for the year ending June 30, 1986 within 120 days after the beginning of the fiscal year.

Lon agreed to discuss the first two items with Prosecutor William Douglas and Mr. Jordan and Mrs. Knealey will complete an annual report and prepare a financial report based on what is available from Mrs. Morris' records.

In other informal discussion, Mr. Jordan was to contact Mr. Keyer concerning getting insurance coverage on the community building through the state.

July 20, 1987

The July 20, 1987 meeting of the Flatwoods Town Council began with the repetition of the oath of office by the following members: Mayor Phillip Knealey, Cecelia Carly Knealey, Ron Jordan Treasurer and members Sue Mayple, Sheila Baughman, Jimmy McCune, Harold McCune, and Robert Spizz.

The minutes for the June 8 and June 15 meetings were approved as read.

The treasurer reported a balance of \$4,668.15 in the general fund after paying <sup>the</sup> election officials, the power bill, and supplies for the Summer Youth Program purchased at Bostin Farm Supply. The Council, on a motion made by Robert Spizz and seconded by Harold McCune, voted to authorize Mr. Jordan to pay these outstanding bills: \$25.98 to ~~Statham State~~ <sup>Bostin Farm Supply</sup>, a bill to B+C Grocery for supplies purchased for the Summer Youth Program, and Disability insurance in the amount of \$125.00 for the next quarter.

A motion was made by Sheila Baughman and seconded by Sue Mayple to pay half of the insurance on the Community Building if it could be purchased through the state risk plan. The Flatwoods Park & Recreation Board would pay the other half. Mr. Jordan was to complete the questionnaire and submit to Harry Kefe.



Under old business the work of the young people involved in the Seaman Youth program was discussed. Two of the workers in particular were mentioned as being good workers and it was recommended that letters of appreciation be written to them.

Mrs. Lincley next read in part a letter she had written to the Prosecuting Attorney concerning the Council's plan of correction for the three violations stated in the Auditor's report. The Council approved the letter. Also Form F-65, WO-2 for fiscal year ending June 30, 1966 was signed by the mayor, recorder and councilman Harold McLene and R. M. Sprigg.

Under old business, setting a speed limit and putting up signs on the corporation road was discussed. It was agreed that more information was needed on the legal procedure to follow.

The Council voted to establish its meeting date for the third Monday of each month at 7:30 p.m.

The mayor requested the establishment of a ~~state~~ street committee & an ordinance committee. The street committee is made up of Ron Jordan, Sue Maple, Harold McLene and Jimmy McLene. Curly Lincley, Sheila Baughman, Robert Sprigg, & Phillip Lincley make up the ordinance committee.

Since Joan Kucaly's three-year-term as the soon appointed member to the Flatwoods Park & Recreation Board expired on June 30, 1987, the Council members agreed to ask David Mayhew to serve in that position.

The meeting was adjourned by the Mayor.

Aug. 17, 1987

The regular session of the Heterwoods Town Council was called to order by the Mayor, the July minutes read and approved.

Under old business, the Council agreed to nominate Scott Gibson to a 3-year term of the Park + Recreation Board as David Maple felt he could not accept since he is out of town so often.

The Recorder reported the Aug. 4 meeting at the Court House which involved municipal elections. Two basic ideas were stressed: writing an ordinance defining town elections and helping the County Clerk's office review municipal voting lists. No one has received the model ordinance from the State Dept., so writing an ordinance was tabled until another time. The Mayor suggested we work with the County Clerk by (1) establishing registration date within the Community and (2) establishing a special meeting to update the current municipal voting registration list.

Mr. Maple suggested the Deed and Lease agreement to the Community Building be kept in a bank deposit box. We will check with the bank concerning cost and availability.

The Treasurer was given approval to pay outstanding bills resulting from the Summer Youth program: (1) B+C Grocery for \$21.18 (2) reimbursement to Mayor for supplies purchased at Jock's and Morrison's Paint, and (3) Jock's,

Acting upon a motion made by Sec  
Maupel and seconded by Robert Speers,  
the Council voted to accept the revised  
budget to reflect actual funds available  
in the General Fund and Coal Severance  
Fund as of June 30, 1987. The account  
# 299-02 for General Fund was  
increased from estimated \$4700.00 to  
\$4934.00 and Coal Severance from  
\$748.00 to \$924.00. The increase of  
\$234.00 in General Fund was added  
to State Dept Fund bringing the  
amount from \$5267.00 to \$5501.00, and  
the \$176.00 in Coal Severance was also  
added to St. Fund, bringing total  
there from 1248.00 to 1424.00. In ~~total~~  
addition the revision reflected an  
addition of \$73.00 designated to the  
Regional Council, the decrease taken  
from the Contract Service Fund. Mrs.  
Knealey is to prepare Form BR 1180  
and the resolution to be mailed to

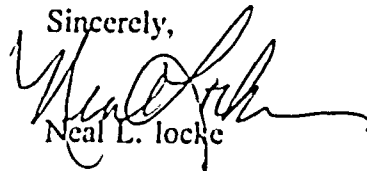
SUBJECT: PROPOSED SEWAGE SYSTEM - TOWN OF FLATWOODS

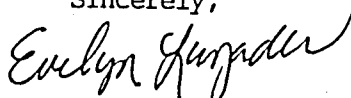
Dear Mr. James:

The adoption of the foregoing resolution having been moved by Scott Gibson, and duly seconded by Burton Butcher, the vote thereon was as follows:

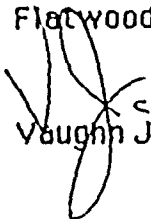
